AMENDMENT NO. 6 - FRAMEWORK AGREEMENT ON FIRST NATION LAND MANAGEMENT

WHEREAS:

Certain First Nations and Canada entered into a Framework Agreement on First Nation Land Management on February 12, 1996 (the "Framework Agreement");

The Framework Agreement was ratified and brought into effect by the First Nations Land Management Act, S.C., 1999, c. 24;

The Framework Agreement has subsequently been amended in accordance with its provisions, and other First Nations have adhered to it;

The Parties wish to further amend the Framework Agreement in accordance with this Amending Agreement;

Schedules 1 and 2 to this Amending Agreement set out the text of the Framework Agreement as amended, with changes highlighted for the convenience of the reader (deletions highlighted in red with strikeouts, as well as additions highlighted in green with underlining);

- 4. Joe Wild Senior Assistant Deputy Minister, CIRNA
 Provided an update on the Canada Wide "First Nations-led process for new
 federal laws and regulations that must affirm and recognize First Nations inherent
 rights, Treaty rights, including Aboriginal title. Chiefs must be part of co-drafting
 any federal legislation for a true nation-to-nation processes to improve the
 livelihoods of First Nations and Canadians." Mr. Wild will be providing a copy
 of his speaking notes to the conference organizers for distribution to the attendees.

- 3. Tour of Musqueam/Squamish/Tsleil Waututh Joint Lands (MST)
 The MST Lands are properties owned through a historic partnership of the
 Musqueam Indian Band, Squamish Nation and Tsleil-Waututh Nation. The 3
 Nations are full or co-owner of six prime properties throughout Metro Vancouver.
 These properties total more than 160 acres of developable land and are currently valued at over \$1 Billion.

The first site that we visited was located across from BCIT in Burnaby – the Willingdon Lands; the second site was located at 3200 East Broadway. I am attaching the brief descriptions of the business sites. The presenters will be provided their full presentations via email. These can be distributed at that time. Due to the traffic and time, we were only able to visit two sites.
