Health Care Assistant / Community Health Worker

patients under the direction of nurses, hospital staff and physicians.

They provide professional care and supervision in protective and supportive health care environments for people who have complex care needs. HCAs typically work in a variety of settings including hospitals, long-term care facilities, group homes, home support and community care.

Health Care Assistants (HCAs) assist in the basic care of

HCAs perform some or all of the following duties:

- Take basic measurements, temperature and pulse
- Give basic personal care under the direction of a nurse
- Monitor patient status and report changes to supervisors
- Collect specimens for sampling
- Provide assistance in patients' daily activities, such as bathing, dressing, grooming and eating
- Move physically challenged patients with special equipment
- Supervise patients' exercise routines
- Maintain an inventory of supplies
- Do various tasks, such as assisting with set up and maintenance of traction equipment, cleaning or sterilizing equipment, and maintaining and repairing equipment

Keys to Success

Oral communication skills are very important for Health Care Aides. They need to be able to explain procedures and respond to their questions and concerns, and to listen to clients in order to assess their needs. They also need to clearly share information about the people they are treating to other members of the health care team. Because they frequently work alone, they need to be able to solve problems and make decisions.

A Look Ahead

Demand for Health Care Assistants is high across BC, and the potential for employment is very good. Home health care is a growing industry, largely due to the aging population.

What You Can Expect to Earn

The median annual salary for a Health Care Aide in BC in 2016 is \$39,431 with hourly wages ranging between \$16.00 and \$26.30/hr.

Title Forum—The proposed St'at'imc Title Forum is scheduled for March 31. Everyone is welcome to this forum. It will be held in ULLUS Centre in Lil'wat. It is an opportunity for open discussion regarding our inherent St'at'imc Title and Jurisdiction.

5 Year Review—Report is provided by the AD HoC Committee set up by the SA.

Treaties—A letter has gone to the treaties that are impacting St'at'imc Territory, advising them that this is St'at'imc Territory. The draft letter was attached for PC at our last meeting.

St'at'imc/BC Hydro Dispute Resolution—Ongoing.

St'at'imc Chiefs Council—A group of former chiefs has been meeting to provide direction to the SCC on future title and rights issues. The SCC has agreed to explore possible Government to Government discussions after discussions on the Timber Supply Review.

Steelhead LNG—This project is paused for now.

Fisheries – The First Nations Leadership Council is inviting all First Nations for consultation on harvest plans for Salmon. PC needs direction on how to respond to this.

Lillooet Tribal Council – Ongoing

Recognition and Implementation of Rights Framework— Ongoing. Should hear more from the UBCIC meeting at the end of February **Environmental Assessment Revitalization** – Ongoing. Should hear more from the UBCIC meeting at the end of February.

Referrals—Ongoing.

PGAC - The governance working group continues to meet to work on issues from their mandate. Please remember the name change from PGWG to PGAC.

Gardeners & Landscapers WHAT IS HIDING IN YOUR SEED?





If you are a gardener, you are likely starting to dream about warmer weather, spring and planning what to plant in your garden. It is important to be aware of what you are buying because invasive seeds can be hiding in your favourite seed package. Here are some tips to avoid purchasing invasive seeds:

- Attend Seedy Sunday, March 3, Rec Centre. It is an Invasive-Free event.
- Learn to identify invasive plants and know their names.
- Read the contents of all seed packages. If seeds do not have the contents on the package, ask for the list especially for wildflower and bee-friendly mixes. Invasives like Batchelor's Buttons are often found in these mixes.
- Ask for a Certificate of Seed Analysis for all seed batches especially lawn and grass seed. The Certificate will list all invasive seeds contained in the seed batch so you can avoid spreading invasives.
- Seeds & insects can also be hiding in soil so it is important to know where your soil and manure comes from and if they have invasives.

T'ít'q'et Council Report

Marilyn Napoleon Report

1. Language, Culture and Heritage:

I have been working with Mildred MacKenzie to design the new signage for the lookout/pull out section of the returned lands at Seton Lake. I am requesting that Council review the text that we are proposing for an interpretive sign for which we have original artwork produced by Luther Brigman. See Attachment A.

We also want Council's input into the large sign which will have information that is readable from the highway. We think the sign should only have the place name: Sk'emqín (Seton Lake IR #5) and the T'ít'q'et logo.

We could also add on the large sign something like "Cultural and Recreational Destination" or words that effect that encapsulates our future plans for the area.

2. Council work:

- Participated in meetings pertaining to lease agreements
- Participated in the development and/or revision of governance and administrative policies as per requirements of the First Nations Fiscal Management Act.

3. Conferences and workshops:

- Attended the Joint 2019 Gathering held from January 22 to 24, 2019. The purpose of the gathering was to facilitate discussion between First Nations leadership and government officials to discuss issues and ways to work together toward advancing First Nation interests. Interesting to me were the Joint Priorities of the AFN and Canada that I have included here as Attachment B.
- Participated in the Risk Analysis session delivered by Brenda Gaertner and Kelsey McDermott to identify potential risks to T'ít'q'et and to mitigate risks.
- Participated in the first day of the Data Management Session Delivered by Sue Senger to gain an understanding of field data collection, data management and using data for decision making as a governing body.

Attachment A

Sk'emqín (Seton Lake Indian Reserve #5) (Sk'emqín means "top" or "source" or "head")

Tmicw ta P'egp'íg'lha – T'ít'q'et (Land of the P'egp'íg'lha – T'ít'q'et)

Seton Lake I.R. #5 is a T'ít'q'et Reserve. It is known as Sk'emqín in the St'át'imc language and is a traditional fishing site and residential area for the P'egp'íg'lha who shared the area with others. Sk'emqín is located on Seton Lake, about 4 miles from T'ít'q'et I.R. #1 and the town of Lillooet. Its place name derives from being near the source or head of Seton River which flows out of Seton Lake into Cayoose Creek ¹.

While P'egp'íg'lha continue to live at Sk'emqín, earlier residents were displaced because of the construction of a fish hatchery. In the early 1900s, pertaining to Sk'emqín, Samphorian (aka Indian Napoleon) stated²: "used to get lots of salmon there, that is why we staked the land and the fisheries people came and put up a hatchery there."

This image, produced by artist Luther Brigman, is a rendition of a traditional St'át'imc fishing camp. The image depicts a fish drying method practiced on Seton Lake prior to displacement. The people in the image are portrayals of early Sk'emqín residents Tsupípnek (Susan Napoleon) and Samphorian Napoleon³.

Sk'emqín is no longer a salmon fishing site as it was prior to the installation of the fish hatchery on Seton River. The P'egp'íg'lha - T'ít'q'et continue to share the area with the public who use the beaches and the lake for leisure activities.

P'egp'íg'lha – T'ít'q'et intends to develop the upper bench, guided by community values, principals and guidelines, as a cultural tourism destination.

Attachment B

Joint Priorities of the AFN – Canada (MOU signed June 12, 2017:

- 1. Policing and community safety issues affecting First Nations;
- 2. Co-development of an Indigenous Languages Act to support the preservation, revitalization and strengthening of Indigenous Languages;
- 3. Work in partnership on measures to implement the United Nations Declaration on the Rights of Indigenous Peoples, including co-development of a national action plan and discussion of proposals for a federal legislative framework on implementation;
- 4. Implementation of the 94 Calls to Action of the Truth and Reconciliation Commission of Canada;
- 5. Ongoing work to develop options for consideration by Chiefs-in-Assembly and federal decision-makers for a new fiscal relationship to ensure sufficient, predictable and sustained funding for First Nations governments;
- 6. Work jointly to decolonize and align federal laws and policies with the United Nations Declaration on the Rights of Indigenous Peoples and First Nations' inherent and Treaty rights;
- 7. Dialogue and planning to identify priorities and measure progress to close the socio-economic gap between First Nations and other Canadians; and
- 8. Such other priorities as may be jointly agreed to.


