Child and Family Services Project

April 2024

T'it'q'et Child and Family Services Project did the soft launch of the project; with Indigenous Services Canada (ISC) Data Strategies Team visiting the community March 11th to 14th 2024. The team of 3; Jackie, Maria and Hillary had the opportunity to interview staff, program managers, administrator, members of Chief and Council. Asking key questions relating to our Child and Family Service, of T'it'q'et's vision for CFS, related data systems, and information management and system requirements and needs.

The theme of the questions that guided the interview focused on the future happiness and healthy children, and what supports are needed to help our children grow as healthy youth and adults.

The team used the 7 values of the P'egp'ig'lha constitution;

- Health; define happy and healthy children and youth
- Happiness; measure happiness and healthier children, youth and families
- Generations; what is needed to help children, youth to know their past generations and care about future generations
- Generosity; encourage children and youth to act generously and with compassion
- Pity/Compassion; encourage children to act with compassion
- Power; support children and youth to know their power
- Quietness; to support children and youth to embrace quietness

As a guide for T'it'q'et Child and Family vision and mission in the development of the data business requirements framework, and data information management system.

Newsletter Report April 2024

The T'ít'q'et Lands Committee is made up of 6 members. The Chairperson is Terence MacLellan, the Vice-Chairperson is Marie Barney, the members are Genevieve Humphreys; Myrus Doss, Marilyn Napoleon and T'ít'q'et Council representative Harold Pelegrin. The Lands and Natural Resources Department currently has two staff members: Lands and Natural Resources Officer Stephanie Louie and Lands Coordinator Dean Billy. The committee and staff have been meeting twice a month on zoom.

Lands Committee

The committee chairperson has registered for a Land Use Planning and Regional Networking session in Richmond in April.

• Law-Making & Enforcement

The committee met with legal counsel from Mandell Pinder at their March 19th meeting to discuss two draft laws: a trespass law and a banishment law. There will be a follow up meeting in person on April 15th at the PCC Resource Room.

• Natural Resource Management

The Lands Advisory Board Resource Centre environmental specialist met with the Lands Coordinator and reviewed their comments on the draft Environmental Management Plan. The Lands Coordinator discussed these comments with the EMP consultant, Dillon Consulting and they have proposed a scope change to provide the additional work recommended by the LABRC. Also, there will be an opportunity for members to provide pictures to include in the Environmental Management Plan. Details to follow.

Lands Administration

Lands and Natural Resources Department staff met with a consultant hired by T'ít'q'et Administration to review their Position Descriptions.

Tribal Chief Report Sidney Scotchman February 2024

Meeting with Reciprocal and PC Director

- Scope of work
 - o 1 on 1 meetings with PC reps to Start. Confidential meetings?
 - o Follow values from families
 - How to deal with conflict of interest
 - o Total 12-15 people to be interviewed
 - o Meet with whole council to gauge availability

SCC

- St'at'imc Chiefs Unity Ceremony
 - o April 11th for unity ceremony, regular SCC meeting April 10th.
 - Location still planned for Lil'wat as tobacco was offered to host in Lil'wat. But could look at Northern Territory if postponed again.
 - O Some chiefs may bring an elder. More info to be sent by Kathleen on what is needed for ceremony.
 - Was discussed whether if a chief is unable to make it, that they send an alternate
 in their place. But was brought up that if a chief is unable to make it, to not send
 anyone as they may not know protocol, and it is the current Chiefs (SCC) that
 need to partake in the Unity ceremony
- Rights and Governance Training
 - o March 14th and 15th with regular SCC meeting on the 13th.
 - Location Pemberton Rec center. No zoom option, but some chiefs mentioned that
 3 days away from their communities is a long time to be away.
- Former Chiefs Advisory Group
 - o Reviewed TOR for Former Chiefs Advisory Group. Was formally called working group, but was decided that this group will be advisory only.
 - o Former chief wanted the group to have VETO over SCC. SCC decided against this.
 - o Group will be consensus voting when needed.
 - o Will make recommendations to the SCC.
- Governance policy
 - Ceremony to swear in SCC chiefs/reps? This was an idea that was brought up to welcome in new chiefs at SCC table.
 - o Have an annual Strategic planning session?

- Honoraria was discussed, due to issues with some chiefs arriving late and leaving early then expecting full days honoraria, honoraria will not be paid if a member arrives late and leaves early.
- Reporting to communities for chiefs. This can be tricky as some times discussion in SCC are to be confidential, was discussed to have a briefing memo done up by SCC Staff for each chief to receive to be used as reporting documentation to their respective communities.

• Independent Power Projects

- o Issue came up that BC Hydro could be looking for IPP's to purchase power from to accommodate increased power usage from electric Vehicles. Currently only one IPP has come up, but more could be on the horizon, SCC will need to be prepared to deal with an IPP that could impact the territory, especially with the current state of the Fraser River and our Salmon.
- Reclaim a Traditional Name
 - Was announced that if you are a survivor of a residential School, you and your family can reclaim your indigenous name. There will be no fee.
- DFO
 - Must continue to lay pressure on DFO for their word to finish the work they promised up Xwisten Fish Ladders. Have any response from them in writing.
 - o Fish Farms
 - Correspondence with Alexandra Morton
 - Mentioned that none of her recommendations in 2019 for modifications were applied.
 - No fish farm company in the world knows how to keep sea lice or disease levels low enough to prevent damage to young wild salmon. DFO aquaculture staff create loopholes for the industry to crawl through all the recommendations that might protect wild salmon.
 - Each year, we learn how much damage is caused by Fish Farms.
- Ministry of Energy, mines and Low Carbon Innovations
 - Work is being initiated on Mineral Tenure Act reform. Support commitments made under the Declaration Act including alignment of laws with the UNDRIP.
 - Consulting with First Nations including Modern Treaty Nations and First Nation Organizations.
 - First Nations pre-engagement sessions March 5th 10am to 11am and March 6th at 1:00pm to 2:00pm
 - o Information sessions for interested groups March 12th and 13th at 1:00pm to 2:00pm
- BCAFN
 - o March 7 and 8th virtual only
- St'at'imc Authority
 - History on creation of the SA and why Lil'wat does not sit at the table, and was mentioned that door remains open if Lil'wat would like a seat at the SA table.

• Reviewed and made some changes to 2024/2025 budget that will be reviewed by PC.

UBCIC

- Gitanyow
 - o Chiefs are watching the current situation with Gitanyow.
 - Background: Gitanyow Heriditary Chiefs are seeking declaration of aboriginal title over Gitanyow Lax'yip which covers 6200 square kilometres near Nass River and Kitwonga River Watersheds in North Western BC. This will be proceeding to trial in October 2024 and will go for 84 days.
 - This court case and what path is laid out could help with bands outside of Treaty
 Process and the recognition of inherent title and rights infringed on modern treaty
 and governments. This will be brought to SCC in near future.
- Intervention in Restoule Appeal
 - Background: a case brought forward by Anishinaabe people of Upper Great Lakes against the government of Canada and Ontario, concerns interpretation of annuities clauses in Robinson – Huron and Robinson Superior treaties of 1850.
 - o UBCIC are considering a leave to intervene in an upcoming appeal to be heard by the Supreme Court of Canada in the case of Restoule v. Canada. Preferably as part of a coalition with First Nations Governments or other organizations interested in intervening in this case.
- Metis
 - Background: over a period of years, the Métis Nation of BC and BC Métis Federation have increasingly asserted that the Métis hav inherent and constitutionally protected rights in BC, including land and water-based rights, and rights to deliver programs and services. Such assertions have resulted in the. Métis being wrongfully consulted and accommodated and included and included in land and water-based consultative processes within BC as rights holders by both the government of Canada and Province of BC. This wrongful consultation and accommodation has resulted in misinformation and misunderstandings about alleged Métis rights in BC and financial and other benefits to improperly accrue to the Metis at the expense of First Nations.
 - In June 2023, UBCIC chiefs council and FNS Chiefs in assembly passed mirrored resolutions that the BCAFN mirrored in October 2023
 - Call on BC and Canada to formally denounce and reject Metis assertions over land and water-based rights in BC
 - Direct the BCAFN, FNS, and UBCIC to convene an all chiefs strategy session dedicated to discussing and strategizing around the issue of Métis colonialism in BC and
